TERMS AND CONDITIONS

- 1. Instruction for Booking.
- a) Applicant must be citizen of India and must be 18 years of age or older at the time of registration
- b) Online application is available on our official website: www.grihawas.com. The application amount can be paid online through the available payment options on the website. For offline applications, applicants may download the from our website, fill it, and submit it along with a Cheque/DD at our Head Office or with an authorized selling agent. The Cheque/DD should be in favor of "SDPLPPL SPLS Awasiya Yojna Collection Escrow Account".
- 2. Registration & Other Charges
- a)Registration Charges, Stamp Duty, Charges and incidental expenses there to as applicable at the time of registration shall be extra and is to be borne by the purchaser.
- b) Other Statutory Charges and taxes as applicable, Levied or Increased from time to time shall be extra and are to be borne by the purchaser.
- 3. Mode of Payment
